>> As you probably know, there has been quite a bit of controversy and upheaval in South Burlington over changing the school name Rebels. Since the superintendent recommended the change and the School Board unanimously approved it, a group calling itself the Rebel Alliance has formed to oppose the change.

>> They have taken on the smokescreen of opposing the school budget to try to mask their intentions and they are trying to get two of their numbers elected to the School Board as write-ins. They are Marcy Brigham and Dan Emmons. >>

>> Although they are trying to appear as separate they are not. Their money is coming from the same people for the same cause which is to restore the Rebel name.

>> The Rebel Alliance is mentioned on the citywide mailing. The Rebel Alliance has also paid for two half page ads in the Other Paper, our local paper. Two half page ads cost more than \$1000 so, as I said, they are over the threshold to register as a PAC.

>> Marcy Bingham and Dan Emmons have two half page ads they share and a couple other single ads. They have registered but have not accounted for their ads in their reports.

>> The Rebel Alliance is having weekly meetings on Saturday afternoons at local restaurants to gather signatures on a petition to put an agenda item on a future ballot to overturn the School Board's decision and to promote the candidacies of Brigham and Emmons. I have no idea how much money they have raised or spent or from whom but with the citywide color glossy mailings and multiple newspaper ads it is obviously in the thousands.

>> I hope you will look into this and that something can be done about this before the election on Tuesday. I wouldn't be surprised to find that they are getting money from out of state racist hate groups or individuals. Regardless, someone is pouring a lot of money into influencing this election and it should be stopped.

**RE: South Burlington Budget Anomalies** 

To Whom it may Concern:

As I am sure you are aware, the city of South Burlington is currently embroiled in a divisive fight to pass a school budget. Through this process, many concerned residents, including myself, have begun to scrutinize the practices of the School Board and Administration. This letter details a specific event which we find to be, at a minimum, questionable. The Administration is on public record (videotaped School Board meetings) offering various accounts of this event. The administrations account was versioned each time more information was publicly released (detailed below).

Given that there have been many recent instances of embezzlement around the State, and that we are at the limits of our abilities to investigate this (and other potential anomalies), the citizens of this community would like an appropriate authority to intervene and conduct a thorough investigation.

Here is a summary of what has been dubbed locally 'Pizzagate':

**12 APR 17:** The high school has a late start and there is a meeting of school staff. The administration orders lunch from Papa Franks of Winooski for a pre-tax total of \$407.65. According to the SBHS Imprest account ledger, the meal is paid for on 12 April 2017 with check no. 629 from this account. It should be noted that at this meal, a letter in support of Superintendent Young and the Administration was made available for staff to sign.

**13 APR 17:** During mid to late afternoon, and based on information from school staff, the facebook group Rebel Alliance openly begins to question the ethics of the previous day's meal. My understanding is that this SBHS Imprest Account is a "Student Activities Account", containing monies raised by students to be spent only on students. At a regularly scheduled School board meeting that evening, acting Principal Pat Phillips addresses the concern with a public statement that he and Lissa McDonald paid for the luncheon *"out of their own pockets"*. Mr. Phillips stated that the intention was to 'treat' the staff to lunch to lift their spirits based on a general sense of low morale.

**14 APR 17:** Knowing that Mr. Phillips was not being truthful in his statement, members of the Rebel Alliance facebook group visited the school offices and demanded to see the ledger. At first they were provided check 6935 written from Lissa McDonald to the SBHS Imprest Checking account for \$407.65 and dated 14 APR 17. They were told the ledger would take a bit to retrieve

and it would be e-mailed to them. When it was made clear that their intent was to wait until the ledger was produced, it was finally presented. You will find copies of that, Ms. McDonald's check, and the Papa Franks Receipt attached. It should be noted that there was no 'Rooms and Meals' tax paid on the receipt. This is clearly stated in the upper left corner of the receipt. Since the administration has stated that this was paid 'out of their own pocket' for colleagues, I would think and expect that tax should be paid. Later that evening, the Rebel Alliance posts the attached evidence on its publicly open facebook page.

**20 APR 17:** At a regularly scheduled board meeting, Superintendent Young was challenged on this issue. He stated that Ms. McDonald's check was improperly dated 'by an office assistant', and that Pat Philips had withdrawn \$250 cash on the morning of the 12<sup>th</sup> and gave it to him (Young). When challenged later in the meeting as to why there was no cash deposit on the register, Young stated that he had misspoken earlier in the meeting and that the cash was given to Ms. McDonald.

To summarize, a \$407 lunch was paid for out of a student focused account which was reimbursed several days after the fact by the administration. It appears the rooms and meals tax on that \$407 was not paid. Throughout this, the Administration has held the attitude of 'no big deal', which readily implies that this is business as usual. Is this really an acceptable means of accounting for a public institution? It certainly does not seem transparent. My concern is beyond this one event. The South Burlington School Budget contains over 9000 OPEN and ACTIVE general ledger accounts (yes, nine THOUSAND). Are there other instances when this type of situation has occurred and perhaps not been repaid? How would we know? Are there other accounts that are used in this way?

I have a hard time believing the administration's most recent version of what happened. Their official story has changed at least twice to this point. With the tension in the community, it has become difficult to obtain information and investigate this further. Please consider following up on behalf of the citizens in this community.
