April, we write to provide you with information that we hope is helpful and to ask you to narrow your request dated July 10, 2018. For civil suits filed against the State in the Civil Division of the Superior Court and U.S. District Court only, there are approximately 400 matters responsive to your request (see attached list from our Civil Division). Providing the initial complaint in each of these matters will amount to many thousands of pages, as most complaints are numerous pages long. In addition, the attached list does not include all potentially responsive matters, including those filed in the Environmental Division of the Superior Court, small claims court, administrative forums including matters filed at the Human Rights Commission (which are generally confidential, see 9 V.S.A. § 4555) and Vermont Labor Relations Board, as well as cases filed in other forums.

We hope this context is helpful to you. We ask that you narrow your request to facilitate processing and reduce costs. Otherwise, we are happy to provide a cost estimate for processing your full request. Just let us know how you would like to proceed.
