Pursuant to 1 V.S.A. § 318(a)(5)(B), the Attorney General’s Office will need to invoke its right to additional time to respond due to the need to gain access to the requested records from the Vermont Agency of Digital Services. We have requested access and not yet heard back. We will further respond within ten business days of receipt of your request.
