I am writing to request public records pursuant to the Vermont Public Records Law, §315 et seq. Kindly forward information responsive to the requests detailed below to agironvives@nclc.org. I hereby request the following records:

Raw data about the debt collection complaints received by the Vermont Attorney General's Office in 2018, including but not limited to fields containing the following information:

- i. The zip code of the individual submitting the complaint;
- ii. Whether the individual who submitted the complaint is a senior;
- iii. Whether the individual who submitted the complaint is an active U.S. Military Service Member or Veteran, or filing on behalf of a veteran; and
- iv. Whether the individual who submitted the complaint is a vulnerable adult;
- v. Whether the individual who submitted the complaint is a fuel assistant recipient;
- vi. Whether the individual who submitted the complaint is a student;
- vii. The name of the company listed in the complaint;
- viii. Any field that indicates the type of debt collection violation reported, whether chosen by the consumer or assigned by someone else reviewing the debt collection complaint; and
- ix. Any information about the resolution of the complaint.

Data is requested in .xlsx or .csv format.

The Vermont Public Records Law requires a response no more than three business days after receipt of this request. If access to the records I am requesting will take longer, please contact me with information about when I might expect copies or the ability to inspect the requested records.
