The only change I would ask is the date window for enforcement actions. I intended Jan. 1 to be the starting date. So January 1, 2010 to April 17, 2019. It would also be helpful if multistate lawsuits were separated from local actions. These changes are in the revised request below.

I greatly appreciate your efforts to assist with this request and refine it in a way that allows Digger to obtain records that will be helpful to our efforts.

I am asking to receive:

- The formal criminal charging documents filed in court by the Vermont Attorney General's Office from May 1, 1997 to April 17, 2019.
- The initial complaint in any enforcement action taken by the Civil Division, as to campaign finance, the Public Protection Division, or the Environmental Division of the Vermont Attorney General's Office pursuant to any statute granting the Attorney General enforcement authority from January 1, 2010, to April 17, 2019. Where no complaint was filed, you wish to receive the settlement document, such as an AOD, Consent Decree, or Consent Judgment, in any enforcement action taken by the same three divisions.
- Multistate lawsuits joined by the Vermont AGO.
- The declination letter or formal criminal charging documents as the result of a police use-of-force or officer-involved shooting review by the Vermont Attorney General's Office from May 1, 1997 to April 17, 2019.

Based on our telephone conversations and my conversations within the AGO, our understanding of the scope of your request is as follows. You wish to receive:

1. The formal criminal charging documents filed in court by the Vermont Attorney General's Office from May 1, 1997 to April 17, 2019.
2. The initial complaint in any enforcement action taken by the Civil Division, as to campaign finance, the Public Protection Division, or the Environmental Division of the Vermont Attorney General's Office pursuant to any statute granting the Attorney General enforcement authority from May 1, 1997 to January 1, 2010. Multistate lawsuits will be included. Where no complaint was filed, you wish to receive the settlement document, such as an AOD, Consent Decree, or Consent Judgment, in any enforcement action taken by the same three divisions.
3. The declination letter or formal criminal charging documents as the result of a police use-of-force or officer-involved shooting review by the Vermont Attorney General's Office from May 1, 1997 to April 17, 2019.

In addition, you are welcome to make arrangements to review the Consumer Division's binders that I mentioned: AODs (1993-2008); Complaints (2003-2008); Press releases (1979-2008).

Please let me know if the above accurately comports with your public records request. I will wait to hear from you with confirmation or edits as to the scope before moving forward.
