Thank you for your inquiry to the Consumer Assistance Program. We will include the emails you have provided as in informational complaint. As such, the information with be available for the Attorney General's Office to review for six years.

I researching information about this business, it appears the business claims to offer a penny auction as well as a multi-level marketing program. You may wish to share with your friends and coworkers that there are a few areas of concern. The Federal Trade Commission issued an alert, outlining the cautions of Penney Auctions. As a newer type of auction, there are many areas that consumers generally do not understand about the auction bidding process. Here is a link to the alert: http://www.ftc.gov/bcp/edu/pubs/consumer/alerts/alt041.shtm

The other area of concern is that pyramid schemes are often disguised by the guise of multi-level marketing programs. In pyramid schemes, most of the individuals recruited end up losing money. Pyramid schemes work by promising persons an opportunity to make money and incur incentives by recruiting others into the program, and then others do the same, creating an endless chain of recruitment. Participants usually spend more than they receive and eventually drop out. —Ultimately losing any funds invested. Here is more detailed information on how Pyramid Schemes work: http://www.ftc.gov/speeches/other/dvimf16.shtm
