I write in response to your Public Records Act request dated October 4, 2019, a copy of which is enclosed for your convenience.

Below are four cost estimate options for your request:

- 1. For all complaints (60 matters) relating to "entertainment, sporting events, ticketing companies or affiliated ticketed events which would include but not be limited to the following keywords: 'tickets', 'event', 'concert', 'box office', 'theater', for the time period of January 1, 2016 through December 31, 2018," we estimate that searching for, reviewing, and redacting the files will come to approximately 570 minutes. Note that there is no charge for the first 30 minutes. At 540 minutes, billed at the lowest possible rate under the Secretary of State's fee schedule (\$.33 a minute), the cost of your Public Records Act request is an estimated \$178.20.
- 2. For all complaints (45 matters) relating to "entertainment, sporting events, ticketing companies or affiliated ticketed events which would include but not be limited to the following keywords: 'tickets', 'event', 'concert', 'box office', 'theater', for the time period of January 1, 2016 through December 31, 2018," *excluding* complaints related to airline and bus ticket sales, we estimate that searching for, reviewing, and redacting the files will come to approximately 485 minutes. Note that there is no charge for the first 30 minutes. At 455 minutes, billed at the lowest possible rate under the Secretary of State's fee schedule (\$.33 a minute), the cost of your Public Records Act request is an estimated \$150.15.

- 3. For a spreadsheet of all complaints relating to "entertainment, sporting events, ticketing companies or affiliated ticketed events which would include but not be limited to the following keywords: 'tickets', 'event', 'concert', 'box office', 'theater', for the time period of January 1, 2016 through December 31, 2018," we estimate that searching for, reviewing, and redacting the spreadsheet will come to approximately 294 minutes. This spreadsheet would contain consumer name, business name, date, matter summary, and claimed losses for each of the 60 complaints. Note that there is no charge for the first 30 minutes. At 264 minutes, billed at the lowest possible rate under the Secretary of State's fee schedule (\$.33 a minute), the cost of your Public Records Act request is an estimated \$87.12.
- 4. For a spreadsheet of all complaints relating to "entertainment, sporting events, ticketing companies or affiliated ticketed events which would include but not be limited to the following keywords: 'tickets', 'event', 'concert', 'box office', 'theater', for the time period of January 1, 2016 through December 31, 2018," *excluding* complaints related to airline and bus ticket sales, we estimate that searching for, reviewing, and redacting the spreadsheet will come to approximately 260 minutes. This spreadsheet would contain consumer name, business name, date, matter summary, and claimed losses for each of the 45 complaints. Note that there is no charge for the first 30 minutes. At 230 minutes, billed at the lowest possible rate under the Secretary of State's fee schedule (\$.33 a minute), the cost of your Public Records Act request is an estimated \$75.90.

Please review these options and respond with how you would like to proceed.
