Per our telephone conversation, I understand that you would like to refine your three Public Records Act requests as follows:

1. Your initial request was: “[A] log showing all public records requests made to the Office, to include date of request, name of requester, subject of request, tracking number and disposition of request...[from] January 1, 2018 to present.”

Pursuant to our conversation, I understand that you would like a copy of the log the Attorney General’s Office ( the “AGO”) keeps to track its PRA requests.

2. Your initial request was: “[C]ommunications to/from the Office of the Attorney General to and from Google and its representatives from May 1, 2019 to present....Please include all email correspondence from Google and its representatives, which typically end in @Google.com or @Alphabet.com. Please also include all correspondence with lobbyists and other representatives of Google.”

Pursuant to our conversation, I understand that you would like communications to/from Google and its representatives and the following: Members of the AGO’s antitrust team, the Chief of the Public Protection Division, the Attorney General, Deputy Attorney General, Chief of Staff, and Chief Assistant Attorney General.

3. Your initial request was: “[C]ommunications to/from the Office of the Attorney General to and from Facebook and its representatives from January 1, 2017 to present....Please include all email correspondence from Facebook and its representatives, which typically end in @Facebook.com or @fb.com. Please also include all correspondence with lobbyists and other representatives of Facebook including but not limited to:
