Dear Corky,

On October 23, 2019 you requested "all available records related to the July 2019 arrest of Bennington, Vermont resident Max Misch for violating a court order barring him from purchasing or possessing firearms or other weapons. That includes an Oct. 17, 2018 statement Misch's ex-wife Lisa Shapiro gave to the Bennington Police Det. Sgt. Cole."

Please find attached the electronic documents presently available in response to your public records request.

Max Misch was arraigned on criminal charges which are currently pending. Consistent with 1 V.S.A. § 317(c)(5)(A)(ii), because some documentation contains information that could deprive Max Misch of his right to a fair trial, we are obliged, at this stage, to exempt this information from disclosure. With regards to the attached documents, pursuant to 1 V.S.A. § 317(c)5(A)(iii) some information has been redacted in order to protect against a possible unwarranted invasion of personal privacy.

We thank you for your patience and understanding as we have worked to meet your request and abide by our obligations under the Vermont Public Records Act.

To the extent you feel records have been wrongfully withheld, you may appeal to Deputy Attorney General Josh Diamond at the address noted above.

A short time later, Lisa arrived at the Bennington Police Department to provide a statement. Lisa advised that the reason she came to report this is because she is done with the abusive way Max talks to her and is tired of Max blaming her for his gun charges.

In Lisa's sworn written statement she writes;

"I am making this complaint against Max Misch, my ex-husband with whom I've had a domestic violence charge against him involving myself when we were married it occurred in 2016, in March. Reason I prefaced the above is because he has an order from Judge Cohen not to contact me in any way. I've received phone calls from "No Caller ID" and he was on the other end. Today 07/02/2019 he called me the conversation was about his weapons charges he began blaming me for his arrest. That its my fault because I confided in my therapist. He blames me and also stated today on the phone, "that I should not have taken him to the store". He states over and over that the trouble he is in is my fault. Max also has asked me to call T.J. Donovan and I should take back my statement because he claims I was not accurate in what I've stated about the amount of ammo he was stacking. I don't know much if anything about guns and I thought it was very odd that with the minimal amount of disability money he gets he has been spending it on ammo and weapons. He continues to talk hateful during that last phone call about the parties involved in this case and I simply don't want to hear about it anymore. I don't want him to call me anymore. Upon this statement he is in violation of his release conditions. His speech was very abusive towards me he kept repeating to me, "fuck you, fuck you, fuck you" called me crazy called me evil completely ignoring his conditions given by Judge Cohen. Before hanging up I told him not to call me again. I also need to disclose this info. Max Misch has since purchased another gun from the armory on Main Street. He deals with Peter at the armory. Due to the conditions he can't bring the gun home but he purchased it soon after the gun charges or possibly before, I think it was after. He paid in full the amount for the gun. Peter @, the armory is holding it for him until he can legally bring it home. He owns it and its waiting for him there. On Main Street in Bennington VT. Addendum-Reason for my initial concern about his guns is for some reason before he bought the illegal magazines in N.H. he had purchased 3 magazines from the trading post in Bennington on 7 North. Upon purchasing them he fully loaded all 3 magazines- 90 bullets, He is not a hunter." [sic]

I followed up with the Bennington Armory LLC located on 445 Main Street, in Bennington VT. The Armory provided me with a receipt dated March 30th, 2019. The receipt shows that Max Misch purchased a JP Sauer, Western Marshall 44 magnum (serial number 272/4) for \$350.00. Max purchased the gun with cash and paid "in-full" or paid the full \$350.00 in cash. The Armory employee advised that they were holding the firearm for Max until his court case cleared up.

Based on the facts and circumstances listed above, Max Misch violated the conditions of release issued to him on February 7th, 2019 by the Honorable Judge William Cohen by purchasing a firearm from the Bennington Armory LLC.
