Dear AGO,

I called the office of the attorney general last week and the person that I talked to on the phone gave me this email address and suggested that I send my inquiry via email

I am a resident of Putney Vermont and became aware, from a current student of Marlboro College, of a situation involving Marlboro College of Marlboro, VT and Emmerson College of Boston, MA. The student explained a situation where Marlboro College was closing and negotiating with Emmerson College to transfer or gift the endowment and real estate of Marlboro College to Emmerson in exchange for taking the students and offering Tenure to the teachers. As I learn more of the situation it appears to be factual.

I recently began to read online through some Facebook groups that were started by some of the Marlboro College Alumni that the process and information has been very secretive on the part of Emerson and Marlboro. The Alumni have expressed frustration about being left out of the process and not receiving any information from the colleges or Trustees. They naturally express concern and disappointment regarding the demise of Marlboro and also offer money and solutions which they perceive as ignored by the Marlboro Administration and Trustees. My interest in this situation is as a Putney Vermont citizen that feels disturbed by the consistent closing of the smaller private non profit colleges though out the country and especially in Vermont. The viability of Marlboro college appears to be significant in my view and also many of the Marlboro Alumni. The college has almost no debt, and endowment of Thirty million dollars (\$30,000,000), and real estate worth at least twelve million dollars (\$12,000,000). The college indicates problems maintaining an enrollment of students at their capacity of about 150 students and this effects their budget and is their stated reason for searching for a college to partner with.

My issue and reason for contact to your office is that if the college ends up closing, the assets, if not returned to the original donors, must be distributed to an equivalent 501(3)c entity. I feel that the potential choice of Emmerson is not appropriate for a number of reasons including, but not limited to its size, location, philosophy and its not a Vermont School. Moreover, the current proposal being considered is that the total assets of Marlboro College, totaling about Forty-two million dollars (\$42,000,000) are being transferred to the Boston, MA school in exchange for direct benefits to private individuals. Any potential benefit to Emerson College is offset and completely negated by the requirement of Marlboro College that they accept the students at their current tuition rates, many of whom pay no tuition, and also offer all jobs to all tenure and tenure track

teachers. It is my concern that this quid pro quo is a backdoor benefit to specific individuals rather than in the best public interest, especially to the Citizens and students of Vermont.

I wish to make an inquiry to the Attorney General as to the present status of this situation within the AG's office. I also wish to be advised, if possible, as to the specific procedure to voice objection to the AG's office regarding any submitted proposals by Emerson College and Marlboro College for the transfer of the Endowment and real estate holdings of Marlboro College to Emerson College.

Josh,

Jamie and I had a conference call w/Kevin Quigley (President) of Marlboro College this morning. They provided context/background for its proposed merger with Bridgeport University (a CT non-profit). We advised him of its obligation to provide notice 20 days prior to consummation and inquired about record-keeping obligations (via Board of Ed and AOE) and he advised they have been in touch on that score. They do not anticipate consummation of the plan until December and are keeping all parties, students, and the public in that area well in the loop. They have been operating at about half the student occupancy load that would be optimal for the school and the expectation is that the merger will help to ensure that a full complement of up to 300 students (currently they have app. 150 enrolled) will return to the campus. Currently, they only have entered into a letter of intent with Bridgeport, but they anticipate providing us with the required notice and a copy of the final merger plan once it is complete and prior to consummation. Their counsel is Jeff McMahon at Dinse who suggested they be in touch with us. Mr. Quigley advised they will keep us in the loop as plans develop.

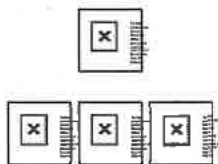

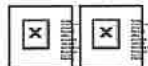
