According to KEI's research, some or all of the trials listed above may have been conducted on the University of Vermont campus.

We are also seeking documents that disclose the number of patients enrolled in any or all of the trials.

KEI is somewhat flexible on the way that the university may respond, if the university has records that are easier to retrieve and contain the information we are seeking. The simplest response would be to provide the dollar number of either the budget for the trials or the actual outlays, and both if that is possible. If such data are available and provided to KEI, then additional documents will not be necessary.

If the University is not inclined to provide such summary data, then the request will involve more extensive records, that the University has in its

possession and that will assist KEI in making reliable estimates of trial costs. These include documents of any kind that report the actual or expected total cost of the trials, as well as documents that report any element of the actual or expected cost of the trials.

Stated otherwise, if a document does not state the total budget or cost of a trial, but lists the actual or expected costs of any aspect of the trial, it would also be subject to this request. If a document states the yearly budget for a clinical trial, that would be pertinent as well. Please also keep in mind that we are also seeking documents that seek the number of patients enrolled in your portion of the trial.
