As you may have seen, the Washington Post published an <u>article</u> today regarding the Stay Home Stay Safe campaign. Others have since followed suit (e.g., <u>WSJ</u>, <u>Politico</u>). We wanted to provide you some additional details about what we have seen in our tracebacks so far.

For background, the call begins with an artificial voice, "This is a test call. Time to stay home. Stay safe and stay home." These calls apparently started in Canada a few months ago before migrating south. As far as we know, in all cases the spoofed called number matches the first six digits of the called party.

We began tracing calls associated with the campaign last week. Those calls led to a UK aggregator that identified its customer as also UK-based but with few details. The server(s) placing those calls appear to be in Germany (but could be controlled from anywhere). Call details from that UK aggregator indicate the caller was placing about 10 calls per second (600 calls per minute) all over the USA. In total the caller placed 278,000 calls on Wednesday via this aggregator. The UK aggregator shut off service to that customer on Friday.

Calls placed yesterday were traced to an aggregator in Dominican Republic that transmitted them to a Belgian wholesaler on their way to the U.S. That provider reports that the caller placed 150,000 calls that day. The information the Dominican provider gave us on the caller also is scant, but we have seen the same French-based originating server IP address (which, again, could be controlled from anywhere) and customer email address in other, more typical robocalling campaigns. The Dominican provider also has shut off service to the caller's IP address.

At least some of the calls placed today that we are tracing came through a provider with a Singapore

address and an Italian phone number. In that case, the IP addresses appear to be London- and Germany-based. Through this call path, 2,000,000 calls were completed yesterday and 500,000 today before a downstream provider blocked it.

We continue to trace additional calls and will provide more information as it becomes available. In the meantime, please feel free to reach out to us with any questions.
