Dear Luis Vasquez:

I am writing in connection with your September 13, 2021 public records request to our office in which you requested, in part, "information on all complaints, claims, or investigations alleging discrimination, harassment, and/or retaliation . . . in employment filed with your office from the year 2016 to the present that include sexual orientation and/or gender identity and/or gender expression as alleged bases for discrimination."

This request is governed by Vermont's Public Records Act, 1 V.S.A. §§ 315-320. The documents and communications covered by your request may contain records which will require reduction and others which may be exempt from disclosure pursuant to provisions contained within 1 V.S.A. § 317.

Information on Specific Complaints. Vermont law provides that records and information obtained by the Vermont Office of the Attorney General ("AGO") during an employment practices investigation, including allegations of alleged civil rights violations, are confidential and may not be produced absent (1) a court order; or (2) consent of the party providing the information. *See, e.g.,* 21 V.S.A. §§ 495(b)(a) (Fair Employment Practices Act (incorporating by reference confidentiality provisions of 9 V.S.A. § 2460(a)(4); 21 V.S.A. § 474(a) (Parental and Family Leave Act) (same). Because neither exception applies here, we are not in a position to provide copies of specific complaints, forms, or other information provided by parties to an employment discrimination complaint. *See id.*; 1 V.S.A. § 317(c)(1)-(2).

Aggregate Data. You also requested certain aggregate data related to employment discrimination claims filed with the AGO. The case management system the AGO utilizes to track this information does not separate out claims on the bases of sexual orientation, gender identity, or gender expression, as you have requested. Rather, our system corresponds to the statutes allegedly violated, in this case Title VII of the Civil Rights Act of 1964 ("Title VII") and Vermont's Fair Employment Practices Act ("VFEPA"). In order to determine which cases are responsive to your request, we will need to conduct a manual review of approximately 288 Title VII or VFEPA case files from the past five years to determine which cases allege discrimination on the bases indicated and to determine the type of conduct alleged, as requested.

The cost to review these records is estimated as follows:

- 1. Investigator review of records: \sim 3 min per file, for 288 files, 864 mins at \$.45/minute (\$388.80)
- 2. Attorney review of records: 30 mins at \$.57/minute (\$17.10)

There is no charge for the first 30 minutes, making the estimated cost equal \$392.40.

Should you wish to proceed with your request, please forward us a check for the total estimated cost of \$392.40. If the actual cost to respond to your request is less than estimated, the difference will be refunded to you.
