40TH ANNIVERSARY CELEBRATION OF COURT DIVERSION TO INCLUDE REMARKS BY AG & OTHERS

AG Donovan will join a celebration of 40 years of Vermont's Court Diversion Program. Recognizing that people and relationships have been harmed when someone commits an offense, Diversion empowers all stakeholders to collectively address the needs of the victim, the community, and the person who violated the law. The first Diversion program in Vermont opened in Washington County in 1976. Programs rapidly developed in other counties, and the Vermont Association of Court Diversion Programs formed in 1979.

In fiscal year 2018, prosecutors referred over 2,600 adults and youth to Diversion. These referrals account for approximately 20 percent of misdemeanor cases filed in criminal court.
