I write in response to your Public Records Act request dated August 18, 2022, a copy of which is attached for your convenience.

For records of complaints concerning "a contractor...Todd Galiano AKA Galiano Construction AKA Galiano Custom Builders, 570 Parker Road, East Wallingford, VT 05742 or PO Box 36, Wallingford, VT 05752, todd@galianoconstruction.com."

The Consumer Assistance Program (CAP) receives consumer complaints via our consumer hotline, standard web form, online scam form, email, and mail. These interactions are recorded as "Complaint Intakes" as well as the "Online Scam Form." Complaint Intakes have a field labeled "Description", where staff take notes during phone calls, copy and paste email reports, view webform submissions, or copy and paste transcribed voicemail messages. All fields of the Online Scam Form are searched. To satisfy your request, our office searched "Galiano" in the aforementioned areas and as an entity in our database. This search located two complaints, one of which is the complaint you filed with CAP. In a phone conversation on Friday, August 19, 2022, you further simplified your request to exclude your complaint and to produce a spreadsheet of the one remaining complaint.

Reviewing and redacting a spreadsheet of the one complaint will come to approximately 30 minutes. Note that there is no charge for the first 30 minutes, thus there is no charge for producing the enclosed spreadsheet. The documents pertaining to your request are attached (Attachment "2022 08 22 Ginnetti – PRR 2022-07196_Redacted.pdf", pages 000001-000003). Personal information has been redacted pursuant o 1 V.S.A. ss 317(c)(7).

	HIF concerns, looking for someone to investigate. Worried about retaliation, as says business has record of this. Has tried to run over another individual with their car, and came to consumers house yelling and kicking items on property. Consumer also mentioned there are others suing contractor, including individual in Grand Isle, but has been advised there is no \$ in it, just would be on record. Consumer heard that contractor works with lawyer who has been advising contractor. Contractor has been registering business with SoS, collecting \$, closing business with SoS and then gets away with it -> Consumer has been in process of building a house for three years. Hired Todd Galiano as contractor, consumer alleges they walked away from project with only 40% of house complete, total of Consumer called city police to report, said consumer could not file a claim since was not the majority provider/payer -> bank has to. According to consumer, bank is not cooperating. City police also said it did not qualify as HIF, as consumer was building a home not improving. Lawyer of consumer's tried to argue that they were improving land, officer said that didnt apply.
