Between July 9 and July 18, 2022, we received nine separate Vermont Public Records Act requests, which were submitted by James Mitchell on behalf of History Associates, Inc. In telephone conversations on July 18 and August 1, 2022, I discussed with Mr. Mitchell the possibility of limiting the scope of a number of the requests, including the first request which is the subject of this letter. As is reflected in a July 22, 2022 email from Mr. Mitchell to me and an August 4, 2022 email from me to Mr. Mitchell, History Associates, Inc., agreed to limit its first request to communications involving our Environmental Protection Division or front office (including anyone who was in those units going back to January 1, 2016). Thus, this response addresses records within the scope of this agreed to limitation.

Please be advised that in response to the request the State will produce 362 records at this time. We plan to produce the documents by providing you access to a State of Vermont SharePoint Site. A guide to accessing the Site is attached. Our paralegal, Natasha Sala, will be reaching out to you by email with an invitation to access the Site and can assist you in doing so.

Please also be advised that we are withholding three records because they are exempt from disclosure pursuant to 1 V.S.A. § 317(c)(4) (attorney client-privilege and work product protection). The withheld records concern legal analysis of potential litigation related to climate change.

Additionally, please be advised that we expect to produce a few additional records responsive to your first request within the next two weeks. I anticipate that material that is exempt from disclosure will be redacted from some of these records. This will be further described in a letter accompanying the supplemental production.

In a September 2, 2022 email, I provided you with a cost estimate of \$575 for your first request. In a September 8, 2022 email, you asked me to proceed with the first request. The charges in connection with the request to date total \$535.80. Please send a check to me payable to the Vermont Attorney General's Office in the amount of \$535.80. Please note that there may be additional charges for additional document review, redaction and production.
